Gary S. Powers, Executive Director

Gary Powers co-founded the Success Foundation of Virginia (TSF), along with Don DeLaney, in October 2018. Gary has served as TSFs Executive Director ever since.

Prior to launching TSF, Gary was a Vice President with Aon Hewitt/Aon Consulting for 18 years and a Partner in the Regional Consulting firm of Williams, Thacher and Rand before selling the firm to Aon in August 1999.

Gary attended Benedictine High School (Class of '71), the College of William and Mary (Class of '75) and completed the post graduate program from The Wharton School in 1981.

Gary has a long history of community service prior to co-founding TSF. He served as a Past Board Member and Board Chair for the Virginia Home for Boys and Girls from October 2003-September 2017. He is the past President for the Richmond Chapter of the Certified Employee Benefit Specialists, Past President of the Richmond Area Group on Health and the COO for the William and Mary Lambda Chi Alumni Advisory Board from January 2018-October 2022.

TSF currently partners with Fostering Acadia, an Independent Living program for young adults who have come through the domestic foster care system. In addition, TSF partners with Commonwealth Catholic Charities through their Independent Living program which assists unaccompanied refugees.

Since co-founding TSF in 2018, TSF has grown from Gary and Don Delaney providing wrap-around mentor support to 54 mentors/tutors today and growing .



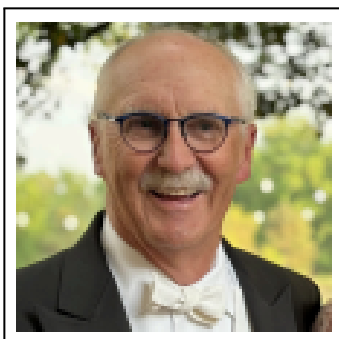
Donald F. Delaney, Board Chair

National President of the Urban Financial Services Coalition Foundation*

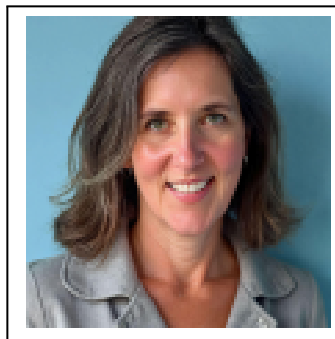

Coordinator for Inclusivity & Program Director, Great Expectations Program for Foster Youth, Virginia Community College System, Richmond, Virginia

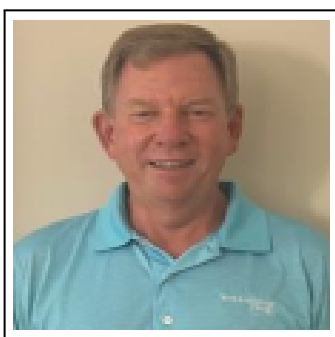

Dr. Strawn received her Ph.D., Educational Policy, Planning & Leadership, Higher Education Administration from the College of William & Mary, Williamsburg, Virginia. Dr. Strawn was honored by the National Association of Social Workers - Virginia Chapter earning the Citizen of the Year award in 2016. Under her leadership, the Great Expectations program won the national Aging Out Institute's 2018 Education Award.

She co-authored a chapter for the December 2018 New Directions for Community Colleges on housing and food insecurity amongst community college students. She also authored a chapter on rural community colleges as a student choice for the same publication.
